AND THE OFFICE OF NUCLEAR MATERIAL SAFETY AND SAFEGUARDS**

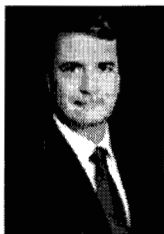
I am pleased to announce the following senior management changes.



Mark D. Lombard has been selected as Deputy Director, Office of Administration (ADM). Mr. Lombard will transition to his new position in February 2017. Mr. Lombard joined the U.S. Nuclear Regulatory Commission (NRC) in 2003 as a senior security specialist in the Office of Nuclear Security and Incident Response (NSIR). Since that time, he held a number of progressively responsible positions in ADM, including Chief, Security Branch, Division of Facilities and Security, and Deputy Director, Division of Facilities and Security.

Since joining the Senior Executive Service (SES) in 2008, Mr. Lombard served in several senior management positions including Director, Division of Facilities and Security, ADM; Associate Director for Space Planning and Consolidation, ADM; Deputy Director, Division of Safety Systems and Risk Assessment, Office of New Reactors; Director, Division of Spent Fuel Storage and Transportation, Office of Nuclear Material Safety and Safeguards (NMSS); and most recently as Director, Division of Spent Fuel Management, NMSS.

Before joining the NRC, Mr. Lombard served in a number of positions in the private sector. He received a bachelor's degree in mechanical engineering from Colorado State University and is a graduate of NRC's SES Candidate Development Program.



Michael C. Layton has been selected as Director, Division of Spent Fuel Management, NMSS. Mr. Layton will transition into his new position in the near future. Mr. Layton joined the NRC in 1991 as a hydrogeologist in the Uranium Recovery Program in NMSS. Since that time, he has held a number of progressively responsible positions within the waste management and fuel cycle licensing programs. Mr. Layton has served as senior technical reviewer, senior project manager, and Team Leader in NMSS. From 2003 to 2008, Mr. Layton served as Chief, Materials, Transportation, and Waste Security Section, and Chief, Materials, Waste, and International Coordination Security Branch, NSIR. Since joining

the SES in 2009, Mr. Layton has served in several senior management positions including

Deputy Director, Division of Fuel Facility Inspection, Region II; Deputy Director for Material Security, NSIR; Deputy Director, Division of Security Policy, NSIR; and Deputy Director, Division of Security Operations, NSIR. In 2015, he was appointed as Director, Division of Security Operations, NSIR.

Mr. Layton received a bachelor's degree in natural sciences from the University of Pittsburgh at Johnstown and a master's degree in geology from the University of South Florida. He is a graduate of NRC's SES Candidate Development Program.
